- Include a copy of the signed purchase agreement if you are purchasing a new home.
- For manufactured homes please include information regarding the size and age of the home and whether it is currently considered real property.

Return your completed application to any AmericanWest Bank Financial Center to be forwarded to the Home Loan Center.

Upon receipt of your application a Home Loan Expert, who is there to assist you throughout the entire process, contacts you to review the application, confirm the loan type, discuss rate options, request any additional information needed, and review costs.
